- 1. Drawing A602 Architectural Schedules and Types Door: Under Door Schedule and Type Notes omit section F. Coordinate Power and Security with Owner Requirements and Existing System. (Doors are not connected to a security or alarm system.)
- 2. Drawings AD101, A401, and A403: Removal and replacement of cabinets in Office B111 shall be Deduct Alternate No. 1. A separate price shall be shown as a deduction from the base bid for this scope should the owner decide to keep existing furnishings in place.

Contractor Questions and Answers:

- 1. Q: Are aluminum doors to be 500 stile doors that are spelled out in the specs or are the AA425 thermal entrances spell out in the material schedule on A601? They are two different types of performance levels on doors.
 - a. A: Specifications should be used.
- 2. Q: Are the aluminum doors supposed to have 10" bottom rails like the spec says or 12" bottom rails off the door schedule?
 - a. A: Specifications should be used.
- 3. Q: Is there a spec or manufacturer specific for the casement operable and awning windows?
 - a. A: No, information provided in the storefront specification may be used.
- 4. Q: SF-3 has columns that are spelled out to be 5" or 7". Are those parts of the building that need to be wrapped in brake metal?
 - a. A: Yes, these are parts that are wrapped in brake metal to match storefront.

1.3 ACCEPTANCE

- A. This offer shall be open to acceptance and is irrevocable for 15 days from the Bid closing date.
- B. If this Bid is accepted by the Owner within the time period stated above, we will:
 1. Furnish the required bonds within seven days of receipt of Notice of intent to Award.
- C. If this Bid is accepted within the indicated time, and we fail to commence the Work or we fail to provide the required bonds, the Bid security shall be forfeited as damages to the Owner by reason of our failure, limited in amount to the lesser of the face value of the Bid security or the difference between this Bid and the Bid upon which Contract is signed.
- D. In the event our Bid is not accepted within the time stated above, the required Bid security will be returned to the undersigned, according to the provisions of the Instructions to Bidders, unless a mutually satisfactory arrangement is made for its retention and validity for an extended period of time.

- B. On Work deleted from the Contract, our credit to the Owner shall be the Architect-approved net cost plus 50 percent of the overhead and profit percentage noted above.
